

# Camping Rules & Regulations



Version 8, revised April 2019

1. In the event of an emergency, dial 911.
2. All payments are due prior to camping. Permanent camp sites require full payment at time of "pulling in".
3. Cleaning of your site including lawn care and leaf removal is the responsibility of the renter.
4. A member of the Chautauqua County Firemen's Fraternity is entitled to one discounted rental for him/herself provided they have a camping card signed within the last twelve months.
5. Quiet hours are from 11:00 p.m. to 07:30 a.m.
6. All campers are required to complete a CCFF Camper Information Form. The same form can be used year after year etc.
7. Once you enter the park, speed limit is 5 mph, this includes driving across any field.
8. Do not walk through or between sites. Please respect the privacy of all campers and walk along the roads provided.
9. The Chautauqua County Firemen's Fraternity is not responsible for any loss or damage caused by fire, accident, or theft.
10. Registered campers are responsible for supervising their children and guests.
11. All campers are responsible for placing their garbage in the dumpster provided, burning of trash is strictly forbidden.
12. One provided picnic table per campsite. Do not remove picnic tables from sites or pavilions without permission.
13. One provided fire ring per campsite. Do not remove fire rings from sites or pavilions without permission.
14. No camp fire shall be left unattended.
15. All children on playground equipment must be supervised by an adult.
16. All children must be on their respective campsites after dusk.
17. Helmets are required for anyone under 14 on a bike, scooter, skateboard, Hoverboard, etc. following NY State Law.
18. One tent is allowed free of charge on a paid campsite in addition to the camper.
19. All small pools or any objects holding water must be emptied when not supervised and at the end of each day.
20. All animals must be kept on a leash. Owners are responsible for the actions and clean-up of their own animals.
21. Animals are not permitted on any of playgrounds including the softball field.
22. All animals are required to have current vaccinations. Proof of vaccinations are required and can requested by Management at any time. Failure to have the correct vaccinations could result in removal from grounds.
23. All alcoholic beverages must be consumed responsibly and no one under legal age shall consume such beverages on the grounds.
24. A driver's license is required to operate equipment or golf carts unless accompanied by an adult.
25. Golf carts are not allowed on the playground. Please park just off the road and walk over.
26. After dusk, working headlight(s) are required on all golf carts, bikes, and equipment.
27. Working tail-lamps are preferred on all golf carts, bikes, and equipment. In place of non-furnished tail-lamps all golf carts, bikes, and equipment must have red reflectors on the back and amber reflectors on the sides.
28. Motorcycles are permitted for transport to and from the park only.
29. Driving nails or other hardware into trees, cutting down of trees and shrubs is prohibited.
30. Anything considered a nuisance, immoral, obscene or offensive will not be tolerated and must be stopped upon request.
31. Firearms, BB guns, use of Paintball or Airsoft equipment is not permitted on the premises unless you have explicit written permission from the Executive Board.
32. Use of campgrounds facilities is to be approved by the Caretaker and is overseen by management. Fraternity members will have priority on vacant sites. Management reserves the right to restrict such use if necessary to ensure maximum availability of the facilities for all campers.
33. Use of the campground and recreational facilities involves the risk of personal injury and property damage. Campers are responsible for the safe use of the facilities, by their families and guest. Campers are responsible for maintaining adequate insurance coverage against the risk of such injury and possible losses.
34. Permanent site retention requires completion of the CCFF Winter Storage & Next Year Reservation Form and deposit. Both are to be turned into the Caretaker as expressed on the CCFF Winter Storage & Next Year Reservation Form.
35. All campers and pavilion renters agree to use the facilities and occupy their site subject to these Rules and Regulations of the Chautauqua County Firemen's Fraternity. Management reserves the right to terminate any agreement and occupation for noncompliance.
36. Our Caretaker can be reached at (716) 595-3776 from 08:00am to 08:00pm. After these hours Caretaker should be contacted only for park emergencies. Please dial 911 for all medical emergencies.
37. All other written policies must be followed at all times, for a full list of policies please see the Caretaker.
38. Management reserves the right to enter any park area when it is considered necessary including to perform inspections.
